## PRIVACY POLICY

Welcome to the CAMED Care Foundation (“we,” “us,” or “our”). We are committed to protecting your privacy and ensuring the security of your personal information. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website, use our services, or engage with our non-profit programs in California.

Please read this Privacy Policy carefully. By accessing or using our website, you agree to the terms of this Privacy Policy.

### 1. Information We Collect

We may collect personal information that you voluntarily provide to us when you express an interest in obtaining information about us, participate in our activities, or otherwise contact us. The personal information we collect may include:

**Contact Data:** Name, email address, phone number, and mailing address. **Donation and Financial Data:** If you make a donation, we collect billing names, credit card numbers, and other financial details necessary to process your payment securely through our third-party payment processors. **Health and Wellness Data (if applicable):** Information related to pain management, therapeutic history, or rehabilitation needs that you choose to share with us when registering for programs or consulting with our staff. **Automatically Collected Data:** IP addresses, browser type, operating system, and tracking data collected via cookies and similar technologies when you navigate our website.

**2. How We Use Your Information** We use the information we collect for various purposes, including: To provide, operate, and maintain our therapeutic programs and rehabilitation support. To process donations, issue tax receipts, and manage donor relations. To send you updates, newsletters, and information regarding our foundation's activities and community events. To improve our website functionality, analyze user trends, and ensure network security. To comply with applicable legal obligations and California state regulations.

**3. How We Share Your Information** We do not sell, rent, or trade your personal information to third parties. We may share your information only in the following limited circumstances: **With Service Providers:** We may share data with trusted third-party vendors who perform services for us, such as payment processing, email delivery, and website hosting. **For Legal Reasons:** We may disclose your information if required to do so by law, court order, or to protect the rights, property, or safety of our foundation, our users, or the public.

**4. Your California Privacy Rights (CCPA/CPRA)** If you are a resident of California, you have specific rights regarding your personal information under the California Consumer Privacy Act (CCPA) and California Privacy Rights Act (CPRA): **Right to Know/Access:** You have the right to request that we disclose what personal information we collect, use, and share. **Right to Delete:** You have the right to request the deletion of your personal information held by us, subject to certain legal exceptions. **Right to Correct:** You have the right to request that we correct inaccurate personal information. **Right to Opt-Out of Sale or Sharing:** We do not sell your data.
